Has no valid visa or residence permit.
- ☐ (C) Še ni potekel čas, za katerega mu je bil prepovedan vstop (93.b ali 93.k člen Zakona o tujcih). *Is a person for whom an alert has been issued for the purposes of refusing entry in the national register.*
- ☐ (D) Oseba predstavlja nevarnost za javni red, varnost ali mednarodne odnose Republike Slovenije (93.b in 93.k člen Zakona o tujcih).
Is considered to be a threat to public order, security or the international relations of the Republic of Slovenia.
- ☐ (E) Oseba predstavlja nevarnost za javno zdravje (93.b ali 93.k člen Zakona o tujcih).
Is considered to be a threat to public health

Detailed reasons for refusing entry:
