## Annex E to the NATO MW COE Operational MOU

### **Framework Nation Support**

- 1. The first responsibility of the Framework Nation is to provide privileges and immunities to the NATO MW COE and its personnel, according to the applicable national and/or international rules, as applicable.
- 2. The Framework Nation will provide:

### a. Free-of-charge:

- The use of facilities located in Poliče;
- ii. Initial furniture and office supplies;
- iii. Initial equipment specified in the NATO MW COE equipment list, as detailed in Annex G of this MOU;
- iv. Security Accreditation Authority to NATO Standards (physical infrastructure and CIS equipment);
- v. Military postage;
- vi. Initial CIS equipment (hardware and software);
- vii. Initial telephone system;
- viii. Initial VTC equipment (Capable of NATO SECRET and Unclassified);
- ix. Initial commercial internet connectivity or other unrestricted access to internet;
- x. Initial NATO SECRET (e.g. CRONOS/BICES/NSWAN) connectivity and related infrastructure:
- xi. Use of SVN Military Training Areas.

### b. Free of charge with ongoing support:

- i. Security infrastructure and services;
- ii. Cryptographic equipment, connectivity, services, maintenance and security;
- iii. The building(s) and supporting infrastructure that houses the NATO MW COE.
- iv. Cleaning service;
- v. Heating;
- vi. Electricity;
- vii. Water and sewerage;
- viii. Optionally providing the registration of the NATO MW COE vehicles as SVN military vehicles.

#### c. At cost support:

- i. Use of external training areas;
- ii. Accommodation facilities (food and lodging);
- iii. Air lift;
- iv. Ground transportation.

# 3. Medical Support

In accordance with Article IX.5 of the NATO SOFA, the NATO MW COE personnel and their dependents will be afforded access to the Slovenian Armed Forces medical and dental facilities, including hospitalisation, for medical care under the conditions applicable to the personnel of the Slovenian Armed Forces.

## 4. Recreational facilities

The NATO MW COE personnel and their dependents will be granted the use of the recreational, sports and welfare facilities and services, on a space-availability basis, under the conditions applicable to the personnel of the Slovenian Armed Forces, subject to national and international law.

# 5. Transportation and parking

FN will provide, free of charge, initial transportation vehicles specified in Annex G of this MOU. Additionally the FN will provide access of vehicles of the NATO MW COE personnel to the NATO MW COE parking area.

### 6. Other assistance

On request, administrative personnel and FN Legal Advisor will assist the NATO MW COE personnel in finding accommodation, establishing bank accounts and providing other practical support related to their assignment to the NATO MW COE.
